- Josephine, achieves her objective of survival by using her body as a form of sexual insurance. She looks to please the men in her world as a way to make sure she has a means to a better life. Though attention and ego-booster appear as if they are important objectives to Josephine, ultimately, they both contribute to her goal or surviving the war.
- Salima is an African woman who is around nineteen years old and the mother of a child. She goes through a challenging experience. She is kept captive and attacked by many soldiers who kill her daughter. The sexual crimes result in Salima's becoming pregnant. In this case, Salima had been abandoned by her tribal groups, therefore, she settled for serving at the brothel. The experiences rape of slavery, and violence raised psychological issues for Salima. She ended up aborting her own baby and committing suicide to terminate her existence in this horrific world. She is a representation of horrifying violence including rape, humiliation, and sexual assault.
- Sophie, an attractive adolescent, Sophie was talented and has a beautiful voice. Christian encouraged Sophie to serve at Mama Nadi's brothel after the soldiers had sexually assaulted Sophie for so long that she has become ruined and hopelessly inadequate as a female. Sophie had been ostracized by her family for the same reason as Salima, both of them has been raped and consequently had been disgraced and humiliated in the eyes of tribal inhabitants.
- Women Discrimination factors in Ruined. There are five factors that found in Ruined drama, such as : Economic Ambition, Social

Contructions of Masculinity, and Impunity.

- The impacts of women discrimination, especially on physical and social matters.
