It can be concluded that poem is continuously changing as indicate by evaluation of taste and stylish idea of progress. It also highlight the personification in Robert Frost's poems, entitle; The Road Not Taken, My November Guest, Stopping by Woods on Snowy Evening and Storm Fear.

Robert Lee Frost or Robert Frost [March, 26, 1874 -January 29, 1963] was an American poet. His work was initially published in England before it was publish in America. He is highly regarded for his realistic depictions of rural life in New England in the early twentieth century and his command of America colloquial speech. One of the most popular and critically respected American poet of the twentieth century, Frost was honored frequently during his life time, receiving four Pulitzer prizes for poetry. He was awarded the Congressional Gold Medal in 1960 for his political works.

Several previous research investigated the Robert Frost's poems. First, the Road Not Taken, who analyzed about An Analysis Unit of Meaning in Robert Frost's Poems [Winda, 2017].

Second, Stopping by Woods on Snowy Evening, who analyzed about symbol [Setiawan, 2014]. Last, Mending Wall who analyzed about metaphor, simile and symbol [Kartika 2020].

Personification is giving human characteristic to inanimate object, animal or idea, empowers inanimate object, inanimate things to act, to do, and spoken like human [Kennedy 2013; Nurgiantoro 2021; Keraf 2021]. The meaning of personification is to humanize or attach human values to something object or living things. From the statement above can be drawn to the conclusion that personification is a figure of speech that gives humanity or relegated nature to inanimate thing that simply has no human. Apart from being given inanimate from of speech, it can be applied to creatures other than human, such as plant and animal. The objective of this study is to find out of the personification in Robert Frost's poems. ## 2. REVIEW OF RELATED LITERATURE

Personification is a figure of speech that represented inanimate things or willing nature to a dead thing as it were having a human nature [Nurgiantoro, 2012]. [Kennedy, 2013] States that personification is giving human characteristic to inanimate object, animal or idea. It is make the reader imagine thing. Apart from being given an inanimate from or speech it can be applied to creatures other than humans, such as plant and animal.

There are main characteristic of the figure of personification make different from other figurative language.

1. The use of human word choice is glued to something other than human.
2. Aimed to describe something with a more concrete image than usual writing.
3. As comparison that gives the effect of human behavior to besides humans.

### 4. FINDING AND DISCUSSION

In this research, the researcher found personification used in Robert Frost's poems; The Road Not Taken, My November Guest, Stopping by Woods on Snowy Evening, Mending Wall and Storm Fear.

#### 1. The Road Not Taken

The example of the sentence of personification in this poem "because it was grassy and wanted wear [line 8]". It refer to *road*. In fact the road cannot want. The narrator has personified "road" in the third line on the second stanza, as if the *road* is human want to wear and tear. The narrator think that at the time the road will better because at the moment *road* were grassy and wanted wear.

#### 2. My November Guest

The example of the sentence of personification in this poem, "my sorrow when she's here with me" [line 1]. As the poem commences, sorrow is personified as a woman and someone whom the poet dearly loves. In the first line "my sorrow when she's here with me" marks the peak of the poet's togetherness with sorrow.

#### 3. Stopping by Woods on Snowy Evening

The example of the sentences of personification in this poem are; first "My little horse must think it queer" [line 5]. In this line the narrator assert that his *Horse* be able thinking like human. Second "To ask if here have some mistake" [line 10]. In this line the narrator assert that his *horse* be able to asking and talking like human.

#### 4. Mending Wall

The example of the sentences of personification in this poem are; first, "my apple trees will never across" [line 25]. In this line is personification represented by word "apple trees". Apple trees is a plant that cannot move, but in this sentence the narrator describes the apple trees can doing like human. Second, "He only says, good fences make a good neighbor" [line 27]. We know that *fences* is a thing, but this sentence explain that fences can make a good neighbor. The narrator gives *fences* human characteristic.

#### 5. Storm Fear

The example of the sentences of personification in this poem are; first, "When the wind work against us in the dark" [line 1]. The narrator describes the wind like human, who can working. Second, "And whisper with a short of stifled bark" [line 4]. This sentence is personification represented by word *whisper*.

It is difficult to believe the wind can whisper however, we know that wind is the air that move and inanimate object.

## 5. CONCLUSSION

Based on the findings of this research, it can be concluded that there is one sentence in the poem of The Road Not Taken, one sentence in the poem of My November Guest, two sentences in the poem of Stopping by Woods on Snowy Evening, two sentences in the poem of Mending Wall and two sentences in the poem of Storm Fear. There are many inanimate object shows in those poems.
